Session A:

Session C:

Participants return and present their progress in creating flow and leveraging pull. Discussions include mass customization, total landed cost, new product development, supply chain audits, and other topics related to Lean supply chains. Participants take the CLM™ exam and leave with an updated project plan and a new 30-day plan of attack.
